## Privacy Policy

## 1. Overview

- 1.1 GLG Corp Limited (ACN 116 632 958) (**Company or GLG**) is listed on the ASX and has its headquarters in Singapore. The Company and its subsidiaries are collectively referred to as the **Group**.
- 1.2 GLG know that privacy is important to you. This privacy policy reflects our respect for your privacy rights.
- 1.3 Like many organisations, we are required to comply with the National Privacy Principles set out in the Privacy Act. This policy describes how we will deal with personally identifiable information that we collect or hold in compliance with the Act.
- 1.4 The principal activities of the Group are being a global supplier of knitwear, apparel, garment accessories and supply chain management operations.

## 2. Personal Information

- 2.1 When we refer to personal information we mean information or an opinion from which your identity is apparent or can reasonably be ascertained.

## 3. Collection of information

- 3.1 We will only collect information about you that is relevant to our business or as required by law. This will often include general information such as your name, address and other contact details.
- 3.2 Where reasonable or practicable we will collect your personal information only directly from you. Our purpose for collecting personal information should be clear at the time of collection. You should contact our Privacy Officer at the address below if you are uncertain. If you do not provide the information we request we may not be able to provide our services to you.
- 3.3 You can generally visit our website [www.ghimli.com](http://www.ghimli.com) without revealing who you are or other personal information. We will not collect any personal information about visitors to the website except when they knowingly provide it.

## 4. Cookies and similar tracking technology

- 4.1 We use cookies and similar tracking technology (collectively, "Cookies") to collect and use Personal Information about you, and to otherwise make interfaces more user-friendly, to provide you a better experience, and to target advertising to you that may be of interest. For further information about the types of Cookies we use, why, and how you can control Cookies, please see our Cookie Policy.

## 5. Using and disclosing your information

- 5.1 We will only use and disclose your personal information as allowed by law. This means we may use or disclose it for the purpose it was collected or as otherwise set out in this policy or

permitted by law. If we want to use or disclose your personal information for any other purpose, we will first seek your consent unless we are not required to by law.

5.2 We will usually only use or disclose your personal information to:

- (a) supply you with goods, services or information at your request;
- (b) maintain our share registry;
- (c) help us improve our website, marketing, goods and services;
- (d) other organisations that help us in our business, such as mailing houses, share registrars, courier companies, contract auctioneers, event organisers, IT contractors, lawyers and accountants;
- (e) tell you about our range of products and services and any new developments, offers or events we think may interest you;
- (f) other parts of our corporate group to help us develop and promote our other products and services and to provide improved customer service. Our corporate group includes entities in Singapore, USA, Malaysia, Indonesia, Cambodia and Hong Kong etc.

## 6. Access to personal information

- 6.1 Please contact our Privacy Officer if you would like to access personal information we hold about you. We will give you access unless we are allowed or required by law to refuse it. We may ask you to pay our reasonable costs of providing access.
- 6.2 If you believe personal information we hold about you is inaccurate or incomplete, please advise our Privacy Officer. We will then take reasonable steps to correct it.
- 6.3 In certain circumstances, we may refuse to give access to your personal information or amend it. Usually we will explain why and, in the case of amendment, make a note that you have disputed the accuracy or completeness of particular information.

## 7. Security and integrity

- 7.1 We will take reasonable steps to keep your personal information secure, accurate, complete and up-to-date. If we no longer require your personal information, we will take reasonable steps to destroy or de-identify it.
- 7.2 Please help us keep your information accurate, current and complete and keep us informed of any changes to your personal information.
- 7.3 We do not take responsibility for the security of information which is outside our control such as when it is sent by post, courier, facsimile or over the Internet.
